#### CAPE ANNE CITIZENS' ASSOCIATION Minutes of Quarterly General Meeting, December 7, 2019


Health Information you may find useful

These are difficult times for everyone in the world. This calls for community support by our near friends and neighbors. Many of us have survived the 1957(H2N2), 1968(H3N2), and 2009(H1N1)pdm09 influenza pandemics before. This one is different from the previous 2002/3 (SARS-CoV-1) and 2014(MERS) epidemics which were both very deadly but quickly controlled by Public Health isolation and tracking procedures [Osterholm, 2017]. There are no current vaccines available to decrease these coronavirus' infection rates, which are quite high. This pandemic is most similar to the 1918/19 (H1N1) influenza pandemic, previously a once in 100-year event. The best current mathematical models that I have reviewed (Imperial College of London, 3/16/20 and Oxford U., 3/20/20) predict that the Suppression Strategy of Non-Pharmaceutical Interventions (NPIs) that are underway will both slow down the saturation of the Intensive Care Units (ICUs) of our health care system *but may also be able to reduce the reproduction number below 1* (i.e. the average number of secondary cases each new case generates). Total suppression may not be possible, however, until a new vaccine is developed and deployed. This may take as long as 12 months.

The NPIs of this mitigation strategy will continue to include: a) *Frequent Hand Washing*, b) home isolation of suspect cases, c) social distancing, d) public event cancellations, e) school closings and f) household quarantine of family members known to be infectious for 7 days from testing positive to 3 days after last symptoms. As I have discussed in my OPED (*The Capital*, 22 March), these NPIs may not be sustainable for as many months as Public Health officials desire. Having said that, the expected fatality rates will still be high, but economically (with an unprecedented public safety net) tolerable. We have seen US fatality rates of over 100,000 in both the 1957 and 1968 pandemics. The current models predict a different pattern of fatalities than recorded in the 1918/19 pandemic, however. The SARS-CoV-2 virus (also referred to as 2019-nCoV and COVID-19) is more deadly to certain demographic groups with weak immune systems than the 1918/19 (H1N1) influenza virus.

The JHU data show a 3-day infection doubling rate, this is quite rapid. If this rate continues, the peak infection rate will probably occur before the end of April (with the aid of the NPIs) and begin to drop off as a large number of us will have developed a herd immunity by having been infected and

recovered. The death rate seems to have stabilized and would indicate that any infected individual should have over 50:1 Odds of surviving the infection. I am only giving you these statistics to assure you that we need not panic. Like a forest fire, however, there will still be hot embers of the virus in our community this summer. A second wave of infection is possible (if not probable) in the Fall.

#### Some helpful Advice from various sources:

- 1. The coronavirus contains an RNA genome, proteins to protect the RNA, membrane proteins to allow the virus to attach to cells, and lipids (fats) as part of the envelope (outer surface) of the virus. The virus cannot replicate/reproduce by itself but must invade living cells to produce new virus particles.
- 2. Because the virus is protected by a thin envelope of proteins and lipids, it is susceptible to degradation outside of livings cells. The time for destruction of the virus depends on factors such as time, temperature, and the surface on which it lands. The longer the time and the higher the temperature, the more likely the virus will be degraded.
- 3. Soap or detergent is considered the best method for killing the virus. Detergents will disrupt the fatty outer layer of the virus, exposing the proteins and RNA genetic material to disruption, denaturation, and degradation. Heat also melts the fats, so use water above 770 F to wash hands, clothes, and everything else. Remember to wash your hands for at least 20 seconds.
- 4. A mixture with alcohol content greater than 65% will also dissolve fats, including the external lipid layer (envelope) of the virus. A mixture of 1- part bleach to 5 parts water will disrupt the viral proteins. Hydrogen peroxide can help after using soap, alcohol, and chlorine (bleach), but it can damage the skin.
- 5. The virus is not a living organism outside of a cell, so antibiotics that are effective against bacteria won't work. There is hope that anti-viral drugs, like those that can treat influenza, will be developed and discovered soon. A severe case could develop into bacterial pneumonia due to a weakened immune system, however.
- 6. The ability of the virus to survive on various surfaces has been tested. Survival of the virus has been estimated to be approximately 3 hours on fabric and porous surfaces, 4 hours on copper, 24 hours on cardboard, 42 hours on metals and 72 hours on plastic. But shaking a product or using a duster can suspend the virus particles so they float in the air for up to 3 hours and can settle in your nose. Therefore, avoid shaking clothing or sheets.
- 7. Virus particles are generally more stable in cold air, such as produced with home or car air conditioners, and they are more stable in darkness. Therefore dehumidified, dry, warm and bright environments will allow degradation of viruses more quickly.

- 8. UV light will disrupt viral proteins and RNA, and UV light could be used to disinfect and reuse a protective mask. However, it can also break down collagen protein in the skin, leading to wrinkles and skin cancer. The virus cannot go through healthy skin.
- 9. Vinegar is not useful because it does not disrupt the fats/lipids in the protective viral envelope.
- 10. Alcoholic spirits and vodka are not likely to be effective since the strongest vodka is only 40% alcohol and 65% alcohol is needed to disrupt the fats in the viral envelope.
- 11. The more space is limited, the higher the concentration of the virus. More open or naturally ventilated, the virus concentration is lower.
- 12. Very Important: you have to wash your hands before and after touching mucous membranes, food, locks, knobs, switches, remote controls, cell phones, watches, computers, desks, TV, etc. And when using the bathroom.
- 13. You need to use moisturizer on dry hands. You are washing your hands a lot, and virus particles can hide in micro-wrinkles or cuts in dry hands. The denser the moisturizer, the better.
- 14. Keep your nails short so that the virus doesn't hide there.

*Food shopping:* 1) pick-up only what you buy, 2) shop for 2-week supply, 3) remove boxes and save only lined content, 4) routinely sanitize half of countertop to maintain a "sterile food section", 5) saturate cleaning cloth with sanitizer and wipe down cans and produce outer wrappings.

#### Note from Treasurer:
