# CAPE ANNE CITIZENS' ASSOCIATION GENERAL MEETING September 16, 2023 Minutes

President Ryan Hostetter called the meeting to order at 9:00 a.m. Attendance was noted on a sign-in sheet circulated during the meeting.

No new members were present.

<u>Meeting Minutes</u>- Minutes for the July meeting, as published in the Tide, were accepted by acclamation.

<u>*Treasurer's Report*</u> – The FY 2023 Fourth Quarter report, as published in the Tide, was accepted by acclamation.

#### **COMMITTEE REPORTS**

- <u>Facilities & Maintenance</u> A few more cuts remain on the grass maintenance contract. The last two cuts will mulch leaves in the common areas. The swimming pier needs repair to the stairs at the entrance and rebuilding the first 40 or so feet to correct some code issues. The pier on Broadwater Creek at the Cape Anne entrance needs repairs to the walkway. We have photographic evidence that this pier has existed at least since the late 1980s and will be considered grandfathered for permits. Both pier projects are considered repair and replace and will require permits.
- <u>*Harbor Master*</u> This has been a slow boating year in many areas of the bay. Low water levels and channel issues have made boating difficult. We have seen more use by paddleboards and kayaks this year. No vandalism has been reported recently. Cameras are in place but there has been no need to review the film. The birds are using the pier, sitting on the pilings. We will look at placing cones on the pilings to discourage them.
- <u>Special Events</u> The Crab Fest will be held this afternoon. We need to look at our community events, what events we hold and how they are managed. Planning the events is a big effort and can be stressful.
- <u>*Community Outreach*</u> We may want to meet with Franklin Manor to see how they handle outreach.
- <u>Plants Committee</u> Phragmites at Cherry Blossom and Broadwater shorelines will be sprayed this fall, and again in the spring. Native plants will be planted on Cherry Blossom later this fall, and marsh grasses in the spring. Plans are to clear the Broadwater shoreline in 2024 and replant with natives. We are planning to plant trees in the common areas to maintain the tree canopy, as many of our trees are nearing the end of their expected life range. All work is done in coordination with the county's critical areas requirements.

• <u>Website and Facebook</u> - All is working well, and Facebook usage continues to grow.

#### **OLD BUSINESS**

• Several facilities maintenance projects, including the pavilion, swimming pier, and pier at the entrance, are under consideration. Once the marina loan is paid off in 2024 we can possibly build funds to cover these or other new projects.

#### NEW BUSINESS

- <u>Volunteers</u> Volunteers for several activities were recognized in the Tide. We would like to also thank Doug Bonner for his efforts in having the osprey platform replaced in Broadwater Creek. The platform was installed in time for an osprey pair to nest and raise successfully a fledgling this summer. Again, many thanks to all who help make Cape Anne the great community it is.
- <u>Broadwater Dredging Project</u> We are looking at offering an easement on the community property adjacent to the marsh restoration area between Cape Anne and Franklin Manor, for the county to use during the project. The property is adjacent to but outside the project boundaries and is not used by the community now. The county does not plan to remove trees. The stone for the bulkhead will be delivered through Franklin Manor. This project will allow dredging of Broadwater and other local creeks to continue by lowering dredging costs.

The meeting adjourned at 9:22.

# Harbor Master

It was a slow boating summer, with light wind and low water. The pier is in good shape, with some minor maintenance needed. Mike will re-stain the few spots that need it. We will try coned covers on some of the pilings to see how effective that is in keeping the birds off before investing in piling covers for all.

# **Committee Reports**

#### Facilities and Maintenance

Lawn mowing has been completed for the year, and the contract will be rebid for 2024. Costs this year were lower than in 2022 for regular maintenance, and we did not have major unplanned expenses. Tree work is still needed. The benches on North Shore and Great Oak parkways are being repaired. We are working on scope of work and permitting for repairs to swimming pier and pier at the entrance, to get cost estimates. These are very small jobs and don't draw much interest from contractors.

#### Special Events

The crab fest was a great success in September. Planning for the event is time consuming and stressful. We would like input about the events to hold going forward. Some suggestions are to scale back the crab fest to a more easily managed event, to hold more events that require little planning, such as standing happy hours (bring your own beverages and chairs), to have periodic pot luck picnics in different loops, to install a community bulletin board. Suggestions and volunteers are encouraged.

#### Plants Committee

Phragmites at Cherry Blossom and Broadwater shorelines were sprayed this fall, following all county regulations (all shoreline work falls under county regulations), and will be sprayed again in the spring. We have planted native shrubs and grasses on Cherry Blossom and will plant marsh grasses in the spring to replace the phragmites. We will submit a county vegetation management plan to clean up the Broadwater Parkway shoreline next year, with the goal to have that ready for a spring clean up project. Wood chips have been delivered to Great Oak Parkway, to spread under existing trees to give them a better environment than grass. As wood chips and time become available, we will expand to trees in other community areas. We would like community input on planting some low-growing native shrubs under the trees in Battee Circle.

Cape Anne has a great history of volunteer involvement in maintaining our community. While people may have less time now for community activities, with work and families, there are still opportunities to take part. One suggestion is to have lists of volunteers for certain areas, such as clean up debris at the pocket beach and other areas after storms, repairs to the piers (already well maintained by volunteers), maintaining the entrance planting bed and other areas. Your ideas are greatly appreciated.
